Just a reminder, for your grazing and/or haying the deadline to sign up and to report your acres is **December 1**st. Going into the 2025 crop year there are NO changes to the Pasture Rangeland Forage (PRF) policy. All county base values, and coverage availability will remain the same as previous years.

Enhanced Coverage Option (ECO) Program Updates:

- ECO coverage is going to be more affordable because of the higher subsidy in 2025!
- Now is the time to sign up for ECO on your wheat. The deadline to add to your 2025 policy is September 30th.
- You may elect ECO regardless of your farm program election.

No Interest Deferral for 2024 Crops

For the 2024 crop year RMA has announced that they will not be granting interest deferrals on premium payments.

This means that if you have an 8/15/24 billing date, and your payment is not made by 9/30/24, a late fee will be applied to the bill.

Don't Wait To Say

Any event that occurs that may adversely affect your yields is something we need to know about. You can never give us too much information. We are required to turn in claims timely or they may not be paid. If anything comes up please notify us ASAP. That's why you have insurance, right?

Important Dates

<u>Annual Forage</u> – Acreage reporting date is based on the month they are planted and must be reported by the 5th day of the month following the planting.

<u>August 15th – September 14th – Projected wheat price is being measured off JUL 2025 KCBT board.</u>

September 15th – Final date to lock in an endorsement for Q4 of 2024 for DRP policies.

<u>September 30th –</u> Final date to make changes or add coverage to your fall crops including wheat and triticale.

October 1st - October 31st - Harvest prices are measured for cotton off DEC board.

November 1st - November 30st - Harvest prices for OK cotton measured off DEC board.


November 14th – Production reporting deadline for 2024 harvested wheat.

November 15th – Acreage reporting deadline for 2025 wheat policies.

November 30th – Final date to make changes or add coverage to potato policies in TX.

<u>December 1st –</u> Final date to sign up or make changes to PRF Rainfall Index policies. Acreage reporting deadline for PRF Rainfall Index policies.
